Sex Offender Registration Requirement

Please carefully review the [Sex Offender Management Procedures Manual Travel Section PR 7.50](#), in order to assess and approve travel of sex offenders under supervision to the District of Puerto Rico. The transferring district of supervision must approve the travel permit and provide the specific transfer instructions. Feel free to contact us if you need assistance during the assessment process prior to approval, or with Monitoring, Restrictive, or Intervention Supervision strategies during the sex offender's stay in our District.

In addition, be advised of the following Puerto Rico's Sex Offender Registration Law requirement regarding sex offender travel:

[Puerto Rico's Law 243 \(2011\)](#), requires that all sex offenders convicted or released into the community, or who are registered as a sexual offender under the laws of any other state, register with local law enforcement (Puerto Rico Police Department) within **48-hours** of their arrival to the district (regardless of the reason to travel). The person under supervision will complete the registration process at the nearest police command center/precinct of the proposed place of stay/residence.
